

Saddlebrook Pool & Clubhouse Rules

(subject to change at any time)

HOURS OF OPERATION:

Pool – mid-May through mid-September, 9am till dusk

Clubhouse – doors open for Pool Season, 9 am till dusk
or by request throughout the year (use email)

*We have a new, **Saddlebrook Events & Community Calendar** (links on the website) where you notify others that your group/function will be occupying some portion of the facilities by (1) viewing the calendar first to ensure there is no other happenings that day and (2) emailing your request to saddlebrookcontact@gmail.com; NOTE no event is ever exclusive to the point where no other residents may use the pool/clubhouse; this is to avoid more than one large gathering at a time.*

RULES

NO access to pool or pool deck after hours for any reason (legal reasons)

NO smoking

NO running/horseplay or diving

NO glass containers

Conduct/Music/Language – Please be aware of your surroundings, as families with young children are often present. Avoid subject matter and actions not generally considered “family-friendly”.

Age restrictions – SWIMMING: All children under the age of 14 must be accompanied by an adult, age 18 or older. GRILLS and/or FIRE PIT: Adults ages 18 and above only.

Cleaning – YOU, the resident (and any guests) are responsible for discarding trash, gathering and removing personal toys and flotation devices and returning furniture if rearranged before leaving the pool area. Adults and teens – *you* are responsible to use the plunger provided and unclog the toilet if you have caused it. Fires must be attended and extinguished, and *you* must clean up afterwards. Grills need to have the ashes moved to the ash cans provided – do NOT put anything other than charcoal in the cans; there are garbage and recycling receptacles on the back porch for all garbage and recyclables. If there are any issues with cleanliness of pool area or if there is an immediate need to close (examples: feces in the pool, water pipe bursts, pump stops working, etc.) please contact them and/or the **pool manager, Joe Mullen 336-971-2605**. If Joe cannot be reached, contact one of other Board officers.

Gatherings/Parties – Calendar as referenced above. Please understand that there can and will be other residents/guests present/arriving that will be allowed to use the facilities. The “booking” is to prevent two or more larger groups from gathering at the same time. No resident/guest is to be turned away due to a pre-set function.

***Non-resident, uninvited individual(s)/group(s)** – Ask! We should all be comfortable being asked if we are a resident/guest (of a resident present with them); if that is the expectation, then there should be no issues. The majority of your annual dues is allocated to maintenance and function of the pool and clubhouse. Those that are present that *do not* pay dues or are *not* a guest of those present that pay dues are officially trespassing and may be asked to leave. If there is a conflict that cannot be resolved directly, or if you confirm that there is/are non-resident, uninvited individual(s)/group(s), do not get into a confrontation. Call the non-emergency Forsyth County Sheriff’s Office: 336-727-2112 or, in the event of a true emergency, 911.

Showers – These are for rinsing only. Shampoo or other soaps can and will get into the pool and may disrupt the chemical balance. This makes it more difficult for the pool maintenance company to maintain. NOTE that Board of Health requires everyone that swims in the pool to have showered themselves clean prior to entry.
